# New Business:

On the agenda is a Resolution to Award 2024 MFT Maintenance Materials for County, and a Resolution to Award 2024 MFT Maintenance Materials for Various Townships. These resolutions are to appropriate Motor Fuel Tax Funds for various materials, for this fiscal year. Bids were taken December 19, 2023. Vendors submitting bids include: Twin Rivers, Calhoun Quarry Mahoney and Beelman Trucking. Prices have increased over all approximately .50 a ton for various rock products, and \$1.30- \$1.40 for crushed slag chips.

## **County Engineer's Report:**

Mr. Klasner reports the intersection light at Delhi Road and US Route 67, has successfully been installed.

There is no update on the Fieldon Hollow Bridge Project. Signoffs from IDOT could potentially take another 3 months. Mr. Klasner will update as he's provided information.

Mr. Klasner visited the Hickory Solar Farm area, where there were previous concerns discussed about the posting of Speed Limit signs. He reports the signs posted are for plant employees and visitors only, and have nothing to do with the general public.

The JCHD Crew completed various tasks in and around the County. They've installed several culverts, completed mowing and assisted several Road Commissioners in their Townships.

# **Miscellaneous Business**

Concerns are proposed, in regards to the culverts on Crystal Lake Road. Mr. Klasner informs the Committee, these concerns should be addressed with the State of Illinois, as it is their duty to maintain this area.

Again, it is noted the community expresses their gratitude to the JCHD Crew, as they continue to show the utmost professionalism, and willingness to assist neighboring Townships.
