1. Call to Order

The Personnel Committee meeting of Wednesday, October 4, 2023 was called to order by Chairman Gary Krueger at 4:00pm.

2. Roll Call

5. New Business –

- 1) Continued Union Contract Negotiations with the PBLC and Jersey County. *The committee opened up with Chairman Krueger asking the members of the PBLC if the items discussed at the previous meeting are as mentioned. Deputy Ayres presented the committee with their pay suggestions. Within the pay structure, they are requesting a four-year contract with a \$2-\$2-\$2-\$2 increase, or a three-year contract with \$2-\$2-\$2 increase.*

6. CLOSED SESSION – *at this time, Jarrod Hayes made a motion to enter into closed session to discuss the pay increase recommendation from the members of the PBLC, Eric Ivers seconded that motion. Motion carried. Entered closed session at 4:05pm. Chairman Krueger asked to re-enter into closed session with a motion by Eric Ivers, seconded by Ken Grizzle at 4:41pm.*

7. OPEN SESSION –*Jarrold Hayes made that motion to enter back into open session at 4:32pm, seconded by Eric Ivers, motion carried. Chairman Krueger brought back from closed session, an offer of \$2-\$1.5-\$1.5-\$1.5 for a four-year contract. The Deputies asked to step away and discuss the offer from the County. Deputy Huitt came back to the bargaining table with a request of \$2-\$2-\$2 for a three-year contract. At 4:56pm the County came back into open session with a motion by Sandy Hefner, seconded by Ken Grizzle. Motion carried. Chairman Krueger stated that the committee agreed not to accept the current request from*

the PBLC. Deputy Ayres asked to step away and discuss the firm offer from the County at \$2-\$1.5-\$1.5 for a three-year contract being offered by the County. Deputy Ayres and the members of the PBLC came back to the bargaining table and stated that they would accept the offer presented from the County at \$2-\$1.5-\$1.5 for a three-year contract. Jarod Hayes made a motion to present the offer to the full board at the October 10, 2023 board meeting, seconded by Sandy Hefner. Motion carried.
