New Business:

The first item on the agenda is the Tabulation of Bids for Maintenance Materials for 2025 in which a bid opening was held on March 25, 2025. This is for all the stone products that will be used this year for the county and townships. These quotes which will allow the county and townships to go to any of the quarries for materials. We received bids from Twin Rivers Stone, Calhoun Quarry, New Frontier Material and Mahoney Asphalt. At the same letting we opened bids for seal coat aggregate and asphalt stabilized base course. This year we did not receive a bid from Beelman Trucking for seal coat aggregate or slag chips. That material is not readily available now. We did receive a bid for Louis Marsch for the asphalt stabilized base course products. The next item is a Resolution to Award 2025 MFT Maintenance Materials for the County, this resolution is for the bid received from Louis Marsch, Inc. for the asphalt stabilized base course materials. Ben Heitzig made a motion to accept the Resolution to Award 2025 MFT Maintenance Materials for the County as presented, seconded by Marty Ward. Motion carried 5-0. The next item on the agenda is a County Maintenance Resolution Supplemental - 2025 Materials. This resolution is for \$270,300.00 to utilize our MFT funds to pay for oil and chipping operations for the year. Ben Heitzig made a motion to approve the resolution as presented, seconded by Dave Crone. Motion carried 5-0.

County Engineer's Report:

Fieldon Hollow Road Bridge – The contractor has drove piling and beginning the concrete pours for the abutments. Approximately 40% of the project has been completed. Hope to have the project completed by the end of May, depending on the weather.

Old Fidelity Road – Is complete except some seed work needs to be completed by FS.

Palomino Drive Bridge – Contractor will be starting April 21, 2025 with the removal of the old bridge.

Otterville Road Resurfacing from Town of Otterville to IL Route 3 – Bids were received by IDOT on March 7, 2025 and the low bidder was CE Mahoney at \$4,379,707.81. I concurred with IDOT on the award to CE Mahoney. Construction will hopefully start in June with completion by October.

Taking bids to replace a mowing tractor along with a mower through the joint purchasing program.

I will be out of the office April 13th through April 18th attending the National Association of County Engineers Conference in Schaumburg, IL.

Miscellaneous Business

Ben Heitzig mentioned the area of pavement on Otterville Road just south of South Centennial Road has settled slightly. Tom indicated this is the area that has settled in the past. We continue to monitor it.
