New Business:

On the agenda is the Tabulation of Bids and Resolution to Award Construction of a new bridge on Fieldon Hollow Road (County Highway 8), Section 22-00060-00-BR. Bids were opened on February 20, 2025 at 10:00 a.m. and received two (2) bids, the engineers estimate was \$457,439.00. Yamnitz and Associates was the low bidder at \$392,313.52 and Stutz Excavating was at \$502,870.50. The Resolution is attached to award construction of this project to Yamnitz Associates for \$392,313.52. Motion made by Ed Koenig and seconded by Dave Crone to approve the Resolution to Award as presented. Motion carried 4-0.

County Engineer's Report:

Fieldon Hollow Road Bridge – The contractor has started work on the project with removing trees and the existing structure. He understands that the county has not formally awarded the project to him but was ready to get started. Hope to have the project completed by the middle of May, depending on the weather.

Old Fidelity Road – Pipe culvert has been installed. Hope to start next week with installation of the riprap and realignment of the road.

Palomino Drive Bridge – Contractor is hoping to remove the trees this week or next week.

Otterville Road Resurfacing from Town of Otterville to IL Route 3 – Bids will be received by IDOT on March 7, 2025 and at that time we will know who the low bidder is.

Working on setting up the MFT Programs for the Townships with the hope to have a letting near the end of March.

The maintenance crew has been replacing pipe culverts, pothole patching along with adding rock along the shoulders and around mailboxes.

Advertised in the paper and on social media for a new employee with applications due by the close of business on March 7, 2025.

Miscellaneous Business

Shelia Beers asked about the gentlemen that attended the last meeting with their concern about Bull Hollow Road in Rosedale Township. Tom Klasner indicated that he had spoken with Darrell Kanallakan, Rosedale Township Highway Commissioner. Darrell is going to add some rock to the road and I also met with Darrell about adding some riprap along the slope of the road.
